#### **RABIES SPECIMEN RESULTS**

- GPHL provides results directly to the submitter (i.e. EHS) by phone (direct line/cell) per info on submission form
- EHS provides results to appropriate persons
- SENDSS lab report is updated by GPHL with results

#### **FOOD/WATER/VECTOR BORNE ILLNESS**

- EH needs to be informed of outbreaks, including those at assisted living facilities, to ensure that the proper EH assessment/investigation is conducted where necessary
- EPI will email both Jon and Jennifer reports pertaining to these and other regulated facilities (Food Service, Pool, Body Art, Tourist Establishments); Jon/Jennifer will notify applicable EH Office staff
- Vector Borne Illness complaints: EPI notifies both Jennifer and Jon of confirmed lab report; Jon/Jennifer will notify applicable EH Office staff and the Mosquito Surveillance Team, if necessary, for risk assessment
- EH staff will then email EPI a written summary report of the findings, including what, if any, action was taken in regards to regulated operations, etc. as determined from the EH assessment

#### **ELEVATED LEAD LEVELS**

#### Scenario 1—Clinic receives initial report

- County Health Department Clinics are to report elevated lead levels to District/Connee Martin
- District/Connee Martin will email Jennifer and Jon regarding any reports received of elevated lead levels from the clinics/SENDSS
- Jennifer and Jon will in turn forward the information to the Lead Investigators (listed below)
  - o Regional Lead Coordinator is Jason Osgatharp (Murray County/Dalton District)
  - o District 2 Lead Investigators are: Bill Ringle & Vicki Hufstetler

#### Scenario 2—EH receives initial report

- County EH Offices are to report elevated lead levels received by their offices to District/Jennifer and Jon
- Jennifer and Jon will in turn forward the information to Connee Martin and the Lead Investigators (listed above)

#### **ANIMAL BITES**

- District/EPI receives reports from Georgia Poison Center via fax
- EPI scans in/emails the report to the county EH office that the victim resides in, copying Jennifer and Jon
  - Email list below by county (page 3)
  - PLEASE NOTE: IF MORE THAN 1 EMAIL ADDRESS IS LISTED, SEND REPORT(S) TO BOTH EMAILS FOR THE RESPECTIVE COUNTY

#### **ANIMAL BITES (CONTINUED)**

- EH office fax numbers remain posted above the main District Office fax machine and are included below (on page 4), should they be needed as an alternate method of getting the reports to the counties
  - If so, the fax with receipt/confirmation page should be scanned into an email to Jennifer and Jon
  - Please note that Fulton County EPI's fax info is included in the list since we still often receive reports out of that area that have to be forwarded there. In such case, the fax should be sent to both Fulton County fax numbers.

Reports received by District 2 EPI for other counties outside D2 will be forwarded to the appropriate EPI and/or EH office by EPI, with assistance of Jennifer and Jon if needed.

- \*\*If medical facility animal bite reporting issues are discovered, Jennifer/Jon will notify EPI for follow up with the facility regarding reporting requirements\*\*
- For Rabies Post-Exposure Vaccination Info (facilities where vaccines can be administered, indigent patient vaccine support info, etc), see page 5 below

#### **MISCELLANEOUS COMPLAINTS**

- District/EPI receives various complaint type reports from Georgia Poison Center via fax
- EPI scans in/emails the report to the EH Office in the county that is indicated in the report, copying Jennifer and Jon (refer to EH email list on page 3)
  - (i.e. complaint regarding hotel cleanliness---send to county of hotel location if provided in report; mosquito/stagnant pool complaints—send to county of address where issue is indicated)
- If limited information is provided in the report or if unable to determine where the complaint should be directed, email to Jennifer and Jon only
