The Social Services Technician will assist in program enrollment, provide community linkages, conduct basic needs assessments, participates in treatment team planning, and find/or offer assistance for clients when warranted/qualified. Assists in dealing with personal and social problems. May provide supportive counseling to clients and families.

### MINIMUM QUALIFICATIONS:

Bachelor's degree in a social services related field from an accredited college or university AND One year experience in a social services related field OR High school diploma or GED AND Three years experience in a social services related position OR One year at the lower level (SST011) or position equivalent.
