#### **JOB RESPONSIBILITIES:**

Under general supervision, provides professional nursing care in accordance with nurse protocols, policies and/or procedures. Cares for population with special needs during disasters/emergencies and biological and chemical protocols.

This nurse will be fully trained as an expanded role nurse, providing care in all public health programs. This position will be based in Habersham County HD but will travel to 12 other health departments within District 2 to provide coverage as needed.

Occasional travel within and outside of the district is also required for training.

### **MINIMUM QUALIFICATIONS:**

Bachelor's degree in Nursing from an accredited college or university AND Current Georgia license to practice as a Registered Professional Nurse AND CPR certification OR Associate's degree/diploma in Nursing from an accredited college AND One year of PHN experience AND Completion of a PHN course within one year of hire AND Current Georgia Registered Professional Nurse license AND CPR certification.
