### JOB RESPONSIBILITIES:

Under general supervision, provides professional nursing care in accordance with nurse protocols, policies and/or procedures. Focuses on the prevention of illness, injury or disability, the promotion of health and maintenance of the health of populations. Cares for population with special needs during disasters/emergencies and biological and chemical protocols.

- Client management (blood pressure monitoring, control support, education) for persons with the diagnosis of primary hypertension. This service may be collaboratively offered with external providers.
- Client management (glucose monitoring, control support, education) for persons with the primary diagnosis of type II diabetes. This service may be collaboratively offered with the external providers.
- Provide management, treatment, control and monitoring of hyperlipidemia, per type II diabetes and hypertension protocol guidelines.

Some travel will be required for training and meetings within and occasionally outside of the district.

## **MINIMUM QUALIFICATIONS:**

Bachelor's degree in Nursing from an accredited college or university AND Current Georgia license to practice as a Registered Professional Nurse AND CPR certification OR Associate's degree/diploma in Nursing from an accredited college AND One year of PHN experience AND Completion of a PHN course within one year of hire AND Current Georgia Registered Professional Nurse license AND CPR certification.
