### Georgia Flu Surveillance Update: Week 33 (Ending August 20, 2022)

As of Week 33, Georgia flu activity is Moderate=7 (on the scale of 1-13). Activity levels are based on the percent of outpatient visits in Georgia due to Influenza-like illness during this timeframe.

For the corresponding week, the percentage of outpatient visits for Influenza-like Illness was 3.9%, the number of influenza-associated death was 0; the number of Metro Area Influenza Hospitalizations was unknown; and reported Influenza Outbreak was 0.
